We will have all the usual Reorientation updates and fresh information about the coming season at the Visitors Center. Beginning last year when we moved Reorientation to the Ecological Research Station, we discontinued providing lunch, so please bring something to eat during our break from noon until 1:00 p.m. We'll arrange for balmy weather so we can make use of the picnic tables outside the Research Station.
